## Aspen Group awards main construction of Vertu Resort to Kerjaya Prospek (M) Sdn Bhd

BATU KAWAN: Aspen Vision City Sdn Bhd, a joint venture company of Aspen Group and IKEA Southeast Asia, has today awarded Kerjaya Propek (M) Sdn Bhd (KPM), a subsidiary company of Kerjaya Prospek Group Berhad as the contractor for main building works for Vertu Resort in Batu Kawan, Penang.

The contract amounting to a sum of RM442 million will see Kerjaya Prospek (M) Sdn Bhd take charge of the overall building works of Vertu Resort, which including all civil and structural works, electrical works, external infrastructure works, automatic waste collecting system, interior design fit-out and landscaping and facilities features.

Vertu Resort is the first high rise urban resort-inspired residential development in Aspen Vision City and will feature a host of impeccable resort style facilities and amenities across 200,000 sq ft of space. Vertu Resort is also only 350 metres away from the first IKEA store in the Northern Region of Peninsula Malaysia and will have an unobstructed view of the 25 acres Central Island Park.

Vertu Resort has opened for registration early last year and has seen tremendous response from the public and a surge in the percentage of sales since it was launched. Every unit in Vertu Resort is furnished with move-in condition and also equipped with the kitchen and home appliances by TEKA. Construction of Vertu Resort has started since early this year and it is set for completion in the fourth quarter of 2020. It has 75% of sales and booking and the Group foresee that it the sales will continue to surge.

"Vervéa is slated for completion and to obtain the CCC in last quarter of 2018. We have also completed the earthworks for both Columbia Asia Medical Centre and IKEA store. Both Columbia Asia Medical Centre and IKEA store are expected to complete in last quarter of 2018 too."

"The progress of the 25 acres Central Park are also right on tracks and currently we are working on the main access roads and landscaping of the entire development. So by 2018, you will see the completion of Vervéa, IKEA store, Columbia Asia Hospital as well as the 25 acres green lung in the midst of this vision city," said Dato' M. Murly, President and Group CEO of Aspen Group.

"The appointment of Kerjaya Prospek also show that we always work with good partners, be it leading global brands or best of Malaysia brands. I hope that through this appointment, both Aspen Group and Kerjaya Prospek can strengthen our working relationship and work closely to deliver quality finishing and product to our home buyers," continued Dato' Murly.

Other components include Vervéa commercial precinct, Columbia Asia Hospital, Vittoria Financial Centre, Viluxe Designer Bungalows, a 4-star business hotel, international school, serviced residences, office towers, a 25 acres Central Island Park and many others.
